Guest passes may be issued for play at the golf course subject to the following:

- The individual or agency he/she represents has significantly promoted play at the golf course or has significantly contributed to the overall well being of the City.
- Guest passes will only be issued to an individual and for a maximum time period of one year.
- The guest pass will entitle the bearer to waiver of green fees only, and shall not include golf carts, food, beverages or equipment.
- The guest pass is not transferable for use by others.

Issuance of guest passes will be subject to the following approvals:

Duration of Pass

1 day  
Up to one month  
Up to one year

Approving Authority

Golf Course Manager  
Director of Community Services  
City Manager

In order to properly monitor the use of guest passes, staff will indicate this information per the monthly report. A copy of the monthly report will then be submitted to the City Council for their review.

City staff which have direct supervision responsibility for the golf course are exempted from green and golf cart fees.
