For High Desert Residents, Businesses & Contractors

Now you can take that left-over paint—FREE OF CHARGE—to one of the authorized drop-off locations in the High Desert:

These locations accept architectural coatings (latex/water based or oil-based), in containers with the original labels. See reverse side for a complete list. Please contact the drop-off location if you have more than 5 gallons of paint to drop off.

Entities with more than 300 gallons of paint may qualify to have the paint picked up directly from their facility—for **FREE**. *See reverse side for details.*

Architectural coatings include:

- Interior and exterior paints: latex, acrylic, water-based, alkyd, oil-based, enamel (including textured coatings)
- Deck coatings, floor paints (including elastomeric)
- Primers, sealers, undercoaters
- Stains, shellacs, lacquers, varnishes, urethanes (single component)
- Waterproofing concrete/masonry/wood sealers and repellents (not tar or bitumen based)
- Metal coatings, rust preventatives
- Field and lawn paints

PaintCare Inc. is a non-profit organization established by the American Coatings Association to implement California's Paint Stewardship Law. PaintCare is establishing hundreds of drop-off sites for postconsumer (leftover) paint at retailers and other sites throughout California. On October 19, 2012, the first day of the California PaintCare Program, 340 new sites started accepting paint from the public, businesses, and contractors. Due to the overwhelming response to the program at the beginning, please call the site prior to bringing them your leftovers to make sure they are able to accept your paint and to check on the quantity of paint they will accept.

To fund this program: PaintCare Recovery Fees are being added to the purchase price of architectural paints and coatings sold in California. The fees are paid to PaintCare by paint manufacturers, then passed down to retailers and eventually consumers. When you buy paint in California, you will probably see a line item called "PaintCare Recovery Fee" on your receipt or invoice for each container. These fees will be used to fund all aspects of the paint stewardship program, including postconsumer paint collection, transportation, recycling, public outreach, and program administration.

Free pick-up for large volumes of paint: Entities routinely generating large quantities of latex paint can overwhelm collection sites. In some cases, PaintCare may service these generators by appointment or leave collection containers on-site for latex accumulation.
