The Project proposes a vesting tentative tract map to subdivide approximately 15.13 gross acres into 53 residential lots for single-family detached residential development. The proposed minimum lot sizes are 7,200 square feet with a net density of 3.7 dwelling units per acre. The average lot size would be 8,368 square feet.
