

**NOTICE OF INTENT TO ADOPT A  
MITIGATED NEGATIVE DECLARATION**

Notice is hereby given that the public agency named below has completed an Initial Study of the following described project at the following location: Northeast corner of Nisqualli Road and Ninth Avenue;

Project Name:	Tentative Tract Map PLN17-00008 (TTM 18487)	
Project Description:	To allow for the recordation and development of a 55-lot single-family residential subdivision (Tentative Tract Map 18487) with 7,200 sq. ft. minimum size lots, on an approximately 19-acre building site that is vacant and undeveloped with an approximate density of 2.9 units per acre. Further, the proposed development will include streets constructed to local roadway standards and include curb, gutter, sidewalk, street lighting and landscape areas within the public right-of-way.	
Project Location:	North of Forrest Park Lane, south of Luna Road, west of Highway 395 and east of Mesa View Drive; APN: 3096-361-02; Within the City of Victorville, County of San Bernardino, State of California, San Bernardino Meridian, Section 28, Township 5N, Range 5W.	
This Initial Study was completed in accordance with the Lead Agency's Guidelines for Implementing the California Environmental Quality Act (CEQA). This Initial Study was undertaken for the purpose of deciding whether the project may have a significant effect on the environment. On the basis of such Initial Study, the Lead Agency's Staff has concluded that the project will not have a significant effect on the environment, and has therefore prepared a Draft Mitigated Negative Declaration. The Initial Study reflects the independent judgment of the Lead Agency.
