NOTICE IS HEREBY GIVEN THAT the Victorville City Council and Board of Directors of the Victorville Water District shall conduct a public hearing on June 7, 2022, at 6:00 p.m. (or as soon thereafter as the matter may be heard) in the Council Chambers of City Hall located at 14343 Civic Drive, Victorville, California, for the purposes of hearing arguments for and against Proposed Resolution Nos. 22-055 and VWD 22-008 which propose to approve the comprehensive User Fee Study Report prepared by NBS (dated May 19, 2022), and adoption of an updated Master User Fee Schedule.


