PUBLIC COMMENT PERIOD AND PUBLIC HEARING FOR THE CITY OF VICTORVILLE 2022–2026 CONSOLIDATED PLAN, 2022-2023 ACTION PLAN, AND 2022 ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING

Program

Pursuant to the United States Department of Housing and Urban Development (HUD) regulations, the City of Victorville and the Apple Valley/Victorville HOME Consortium have prepared a 2022-2026 Consolidated Plan, 2022-2023 Action Plan, and 2022 Analysis of Impediments to Fair Housing.

The 2022-2026 Consolidated Plan is a planning document that identifies the City's affordable housing and community development short and long-term needs, priorities, and goals. It also outlines the strategies and timelines for achieving the City's goals as required to receive an estimated \$7.5 million of federal Community Development Block Grant (CDBG) funds combined over the five-year period of the Consolidated Plan beginning July 1, 2022, and ending June 30, 2027, to cover grant years 2022-2026.

The 2022-2023 Action Plan is the City's application to HUD for CDBG funds delineating the projects to be undertaken during the program year. The Action Plan identifies the federal and other resources expected to be used to address the priority needs and goals noted in the Consolidated Plan.

The 2022 Analysis of Impediments to Fair Housing is to assist the City in identifying fair housing issues, contributing factors, and goals to affirmatively further fair housing.
