Mandatory Commercial Recycling Program

MANDATORY COMMERCIAL RECYCLING: Effective July 1, 2012, State Law Assembly Bill 341 requires all businesses and “public entities” that generate 4 or more cubic yards of trash per week to implement recycling. Multi-family complexes with 5 or more units are also required to recycle. In addition, Chapter 6.36 of the Victorville Municipal Code requires the separation of designated recyclable materials from trash; per Section 6.36.113, it is unlawful to place designated recyclables in solid waste containers.

The City of Victorville, and all CA municipalities, is required to develop and implement programs to cut the amount of waste sent to landfill by 50% per Assembly Bill AB 939, passed in 1989. Businesses produce over 50% of Victorville’s waste, so your participation is essential for the City to meet the 50% goal.

SERVICES AVAILABLE: The City of Victorville, through its hauler Victorville Disposal, provides a variety of recycling services to its commercial sanitation customers. These services include:

- **Small Can Service (Blue Cart Program):** Once per week service. Multiple cans available.
- **Dumpster Service:** Dumpsters ranging in size from 1.5 to 4 cubic yards can be serviced from 1 to 6 days per week.
- **Roll-off or Compactor Service:** 30 cubic yard dumpsters, serviced from 1 to 6 days per week.

In addition, businesses may want to consider these other recycling options:

- **Recycle On Your Own:** If you would like to haul your own recyclables, the City can provide you with a list of recycling centers that will purchase corrugated cardboard and CRV materials. The City also has information on where to recycle pallets, scrap metal, wood waste, and construction and demolition materials.
- **The Business-Community Recycling Partnership (BCRP):** If you don’t want to take the time to haul your own CRV materials, then how about hooking up with a non-profit group? The City will supply your business with FREE recycling containers to collect CRV beverage containers. The City will also provide you with a list of non-profit groups that are willing to collect the CRV when your containers are full. The non-profit redeems the CRV and uses the funds for its mission.

WHAT CAN BE RECYCLED? Through the City’s program, your business can recycle all clean, dry papers, cardboard, along with glass bottles & jars, tin and aluminum cans, plastic bottles, tubs, jars and trays #1 - #7, and all CRV beverage containers. All these materials can be mixed together in one container.

In addition, the City can help you find markets for scrap metal, pallets, wood waste, grease/rendering materials, concrete, and asphalt. If your business has large amounts of cardboard or CRV, the City can also supply you with a list of local companies that will purchase these items from you.

RECYCLING IS GOOD FOR BUSINESS: Recycling also makes good business sense. Most businesses can reduce their costs for trash service by recycling. If you have a large volume of recyclables, you may be able to sell your materials. Your customers will appreciate your participation, and you will be sending the message that your company cares about the community and the future. Businesses which recycle can receive a certificate of appreciation from the City.
